As per clause XX - Election - of the bye-law of the Society, the President, General Secretary and Treasurer of the Federal Bank Officers' Association shall become members of the Managing Committee as President, Secretary and Treasurer of the Society respectively. Election will be held for remaining 9 vacancies in accordance with clause XIX and XX of the bye-laws.

If the number of candidates is more than 9, election will be held by secret ballot electronically in the General Body Meeting scheduled to be held on Sunday 29<sup>th</sup> December 2019 at 11.00 a.m.

Photo ID (Any one of Bank ID, Electoral Card, Passport, PAN Card or Driving Licence) is to be brought for casting the vote.



### **Special Resolution**

If any member wishes to move any special resolution in the General Meeting, it shall be in accordance with the following provisions of the bye-laws.

“Special Resolution” shall mean the resolution passed by a majority of not less than three fourths of such members of the Society entitled to vote and are present in person at a general meeting of which notice of not less than such period as may be prescribed has been given specifying the intention to propose the resolution as a special resolution, provided, the members entitled to vote at any such meeting may agree to accept a shorter notice. (Clause I ( iv ) of the bye-law)

Special resolution sent by members are to be received at the Regd. Office of the Society before 5.00 p.m. on Saturday 14<sup>th</sup> December 2019. Text of special resolutions if any shall be posted in the website of the Society on the next day.
