- 3) As per Clause XII (i), the members in the membership register of the society who had paid the full admission fee/membership subscription as on 30th June 2025 of the election year shall be entitled to exercise their voting rights in the election of the members of the Committee.
- 4) Members who defy/defaults to remit amounts which are due to the Society by way of subscription or such other dues upto 30<sup>th</sup> June 2025 shall not be entitled to contest as a Candidate for any of the Posts in the Society.
- 5) The List of Members of the Society as on 30<sup>th</sup> June 2025 is uploaded on the FBOAES Website.
- 6) The Annual General Meeting is proposed to be held at FISAT, Hormis Nagar, Mookkannoor on 26<sup>th</sup> October 2025. Online voting shall be held along with the Annual General Meeting. Voting shall be online and will commence at 11:00 AM on 26th October 2025 and end by 2:00PM on the same date.
