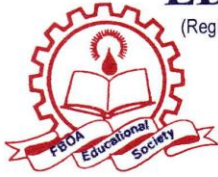

B.Tech Admission 2019 in FISAT to the Children of FBOAES Members Under FBOAES Quota in Govt. Allotment

As per the existing agreement between Kerala Self Financing College Managements Association and Govt. of Kerala, Commissioner of Entrance Examination shall allot 15% of the total seats from among the students belonging to the Community / Registered Society / Registered Trust to which the educational agency belongs, on the basis of merit. Accordingly Children/ Grand Children of Member / Patron of FBOAES are eligible for admission under this Govt. quota. The fee will be only the fee as applicable to Government quota.

Children/Grand children of FBOAES members/patrons seeking B.Tech Admission in FISAT under Govt. Community/Society Quota should file their options with Commissioner for Entrance Exams (CEE) as per the schedule published in CEE website www.cee-kerala.org to be considered for allotment under FBOAES Quota. Please visit www.cee.kerala.gov.in or www.cee-kerala.org

Those students who seek admission under Community/Society quota shall have to upload their marks for ranking within the stipulated time period and submit online options in CEE website to the desired courses in FISAT (**College Code: FIT**) when called for. They also have to remit the fee shown in the allotment memo at the selected branches of the specified Bank without fail.


